#### **Dear David**

Building defects was again a key focus for OCN this month, dominated by our advocacy on the Government's Design & Building Practitioners Bill 2019 introduced into Parliament at the end of October. The Bill is only one step of many needed for real change. OCN is continuing to press for amendments that would provide more immediate material consumer protection for new apartment owners.

The ABC 7.30 Report series on building defects in apartments was comprehensive and helped keep focus on much needed regulatory change. We are grateful for those OCN members who offered to have their stories told.

Our thanks too to our Premium Sponsor, <u>Strata Plus</u>, for involving OCN in their October client information event. It provided great insight into the importance of a good relationship between Committees and Strata Managers and it is always good meeting other owners working to make their strata communities better.

Finally, it has been great to see both new and more experienced members continuing to learn from each other on the members only forum. The forum has again been active this month covering issues such as fire services cost management, by-law enforcement options, safety responsibilities for contractors working on common property, and pets in apartments to name a few. ### **Building Stronger Foundations**

The Bill is very much a 'first step' in re-regulating residential apartment construction and relies heavily on regulations that have not yet been developed. The timing for this is uncertain, it is a very significant piece of work, and Christmas is approaching. In the meantime, thousands of new apartment owners have entered the market since Opal Tower hit news on Christmas Eve last year.

OCN is continuing to press for some simple amendments that would immediately improve the consumer protection available to new apartment owners. We have excellent support from specialist lawyers in the field providing significant hours at no charge. This input is invaluable. We remain hopeful that our further engagement with the Minister's staff and Members of Parliament will help make a real and timely difference to new apartment owners.

In related activity, OCN will sit on the Building Reform Expert Panel recently established by the Minister for Better Regulation and Innovation. We are also represented in a stakeholder group created by the NSW Building Commissioner, Mr David Chandler, OAM, looking at non-legislative levers to effect culture change in the sector.

There is still a very long way to go in achieving adequate consumer safeguards for new apartment owners. In the meantime we continue to urge extreme caution when purchasing new apartments, particularly in buildings over three levels or 'off the plan'.

#### **Short Term Letting**

OCN's focus is now on ensuring that there is a mandatory registration system, and that the registration system is independent of the tourist industry. It will not be possible for the new regime to commence this year. OCN will put out an updated fact sheet before Christmas.

OCN members can purchase the OCN pro-forma by-law expertly drafted and tailored to the forthcoming legislation that allows a scheme to prohibit STL by non-resident owners.



#### **Other Activity**

We also participated in Digital Survey Plans roundtables as Land Registry Services grapples with the large volume of data available but not accessible.

We brought your by-law concerns to Land Registry Services; like what happens when you discover a key Special By-Law is omitted from consolidated by-laws?

And we're deep in conversation about a possible Strata Register.

# **Appeal Tribunal Upholds By-Law Banning Short Term Letting**

You have been told time and time again that a body corporate cannot make a by-law banning short term letting.

But a strata community put in place a by-law prohibiting lettings of less than one month as a means of protecting the special residential amenity of their community.

The by-law was overturned by the Commissioner's Office. But the QCAT appeal was successful. The reasons given by the appeal tribunal give a most compelling case for why a body corporate's power to make by-laws is robust, and rightly so.
